### **Do you:**

- Have low or no earned income?
- Have a child who lives with you under the age of 18?



### **Have you:**

- Never filed taxes, or not filed in recent years (2019-2021?)
- Not received stimulus payments for you and/or any dependents?

### **If you answered yes to any of these questions:**

Submit a tax return to the IRS and you could receive any missing stimulus payments for you and/or child tax credits for your eligible children or dependents (**between \$600-\$3,200 per person!**)

You can **still file tax returns from 2019-2021** and get the money!
